Modified bib has extra wraparound width, providing additional comfort and limiting penetration of sawdust. Pack: carton.

**Professional chain-resistant gloves**

TO EC STANDARDS

EC approval, standards EN 420/03, EN 388/03, EN 381-7/99. PPE category 2, class 2 (resistant to chain speeds of up to 24 m/sec). Made of 1.2 – 1.4 mm gauge full-grain cowhide. Double thickness on palm and thumb to provide high strength and absorb vibrations. Elasticated cuff preventing the entry of foreign matter. Leather reinforcement protecting wrist artery. Further reinforcement stitched on the back protects against wear. Chain resistant protection applied to back of left glove only, in conformity with current safety standards on working with chainsaws. Pack: pouch.

**Chain resistant forestry boots**

EC approval, standards EN 344, EN 345-1 (class SB-E-P), EN 381-3 (class 3). Personal Protective Equipment (PPE) category 2 - class 3. Resistant to chain speeds of up to 28 m/sec. Knee-high with rear laces, equipped with cotton inner boot, insole in absorbent felt, ankle guard reinforcement, reflector. Anti-crushing toecap, anti-piercing soleplate and blade blocking protection on top of foot and on shin. Sole features "carrarmato" style lugs. Pack: carton.

**Chain-resistant forestry boots**

EC approval, standard EN ISO17249 (class 2), EN-ISO20344, EN-ISO20345 (class S3CI-HRO). PPE category 2 - class 2. Resistant to chain speeds of up to 24 m/sec. Boots with full grain water-resistant leather upper, laced to the top, and inner of leather and breathable fabric, impact-resistant padding at calf height, anatomically contoured footbed of antistatic "EVA" with high sweat absorption / deabsorption coefficient. Sole in vulcanized HRO rubber (resistant to temperatures up to 300 °C) with deep cleated tread, puncture resistant sole plate, rigid toecap and blade guarding from instep up to shin, and on the sides.
